

ALTAVISTA ON TRACK - CLASSIC CAR SHOW

RULES & REGULATIONS

The continued success of AOT Uncle Billy's Day Classic Car Show events depends on cooperation between exhibitors and show management. The following rules and regulations have been established for the benefit of both parties. Failure to follow these rules and regulations may result in disqualification.

Exhibitors should realize they are on display, along with their vehicles. All exhibitors must adhere to a reasonable standard of dress and conduct; clean, presentable attire is required. Lounging in the exhibit area is prohibited. Please contact the show producer or show chairman to find the location of the Exhibitor's Lounge or a suitable place for you, the exhibitor, to gather. Do not deface the show building or leave boxes of debris in the exhibit area.

1. No alcoholic beverages will be permitted at ANY time. Violators may be subject to disqualification. Alcoholic beverages are only allowed in the roped off section of the festival.
2. Dogs and pets are not allowed during the festival or car show.
3. Personal coolers are not allowed during the festival or car show.
4. All vehicles and displays should be presented in good taste. No obscene or suggestive items will be allowed.
5. Entrance to the Uncle Billy's Day Classic Car Show will take place from 9:00AM until 1:00 P.M. Saturday, June 1, 2019.
6. Fees WILL NOT be refunded to disqualified, late entries, or no-shows
7. At no time will careless or reckless driving by exhibitors or unnecessary noise from entries be tolerated; this includes during set-up and close-down hours.
8. "Camping out" with motor homes, RV's or trailers will not be permitted.
9. A 10' x 10' area will be provided for each entry fee.
10. Entries may not be dismantled prior to completion of the entire show. Awards will be announced at the end of the show.
11. All vehicles and entries must be compatible with any restrictions or requirements imposed by AOT or required by Federal, State, and/or Local law.
12. Sponsorship or advertising signs are not permitted during the car show.
13. Show producers, show chairmen, show personnel, Altavista On Track, Altavista Chamber of Commerce, or the Town of Altavista, AND/OR town officials may not be held responsible for ANY liability, to include but not limited to, injury/death of exhibitor or theft/ damage to vehicles.
14. CLASSIFICATIONS:
 - a. Exhibitors may enter into one of the following categories for judging:
 - i. Original Factory Type¹ Earlier- 1959
 - ii. Original Factory Type¹ 1960 - 1969
 - iii. Original Factory Type¹ 1970 - 1979
 - iv. Original Factory Type¹ 1980 - 1989

1. 100% street legal and as close to stock/factory style as possible with proper licenses and registrations
 2. 100% street legal non-stock
 3. Non-Stock - street legal not required.

- v. Original Factory Type¹ 1990 – Newer
 - vi. Hot Rod²
 - vii. Racing³
- b. All entries must be operable within the definition of their classification. Determination will be strictly up to the AOT official and supervisor.
- i. All entries must be able to start, pull forward, backward, turn right and left, and stop (by applying brakes) under their own power.
 - ii. Vehicles manufactured with 4-wheel brakes must have all brakes operable.

15.JUDGING

- a. Popular vote will determine the “People’s Choice Award”

16.It is the responsibility of the exhibitor to know if his/her entry violates any of the rules and regulations of the AOT “Uncle Billy’s Day” Classic Car Show.

17.ALL DECISIONS ARE FINAL AND NOT SUBJECT TO PROTEST

18.VIOLATION OF ANY RULES OR REGULATIONS WILL/MAY RESULT IN DISQUALIFICATION WITH NO RETURN OF ENTRY FEE.
